Is it time to upgrade your AEDs?

Your automated external defibrillator (AED) is one of the most important safety tools to have ready for your employees, customers, students and the public. As equipment matures, it is important to evaluate your AEDs to determine if it is time for replacement.

Replacement checklist

- Has the warranty expired?
- Does the AED use outdated monophasic technology?
- Are accessories and disposables no longer readily available?
- Are the instructions simple enough for lay responders?
- Does the AED provide CPR coaching and feedback?
- Do users have to stop CPR for rhythm analysis?
- Can the device safely be used on children and adults?
- Is your monitoring/maintenance program not as efficient/effective as you'd like?

One (or more) of these reasons is enough to consider upgrading your AEDs to a fully connected LIFEPAK AED Response System.



Age of device

To save a life, you want your device to be in the best condition. In AEDs, batteries and internal components age and lose effectiveness over time. This aging effect occurs even with AEDs that have never been used. The length of the warranty is a good guide to expected peak performance. Once an AED has an expired warranty, it's wise to consider replacing it.

Cost of ownership

If your warranty is expired, it can become cost-prohibitive to service your AED. Check for any take-back or trade-in discounts that can help offset the cost of replacement. When it's time to replace your AEDs, ask about the warranty period of your new devices. Physio-Control now offers an eight-year warranty on the new LIFEPAK CR2 Defibrillator—one of the longest warranties on the market today.
